

LOCA LAKE REGULATIONS

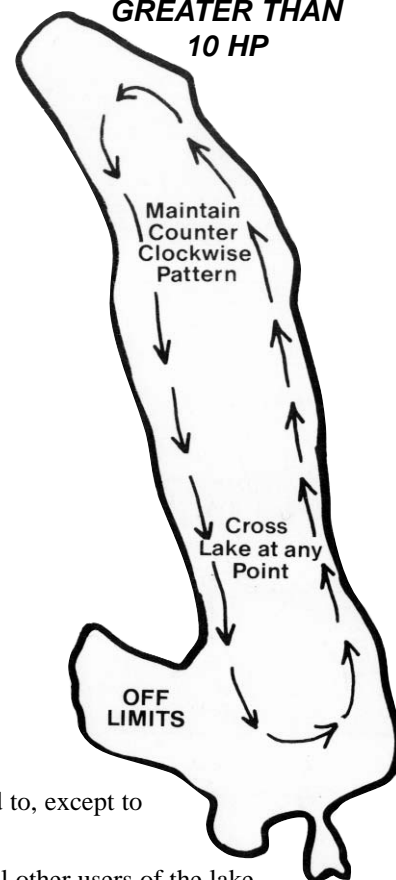
- 1 • Watercraft of every type must be registered with the LOCA Boat Compliance Committee. All watercraft must display the red and white LOCA membership area number decal on both sides of the watercraft and display the current LOCA year decal next to it. All decals are to be located between the center and stern of state registered watercraft and on all other watercraft in a location so that they are visible when the watercraft is in the water with occupants.
- 2 • Motorized craft must display state registration number and must comply with all New Jersey operating regulations. All boats and motors must be registered with the LOCA Boat Compliance Committee.
- 3 • Operation of motorized craft are strictly limited to certain hours of the day in accordance with the following schedule: (except electric motors which may be used from dawn to dusk).

* Dawn is defined as 1/2 hour before sunrise. Dusk is defined as 1/2 hour after sunset.

- 4 • The power boat greater than 10 Hp and ski pattern is counter clockwise and must be strictly adhered to, except to pick up a downed skier/rider in tow.
- 5 • Skiers/riders in tow shall comply with New Jersey State regulations and shall respect the rights of all other users of the lake.
- 6 • Motorized craft operating in the area between shoreline and floats shall proceed at slow trolling speed only.
- 7 • Swimming and bathing shall in general be confined to the area between shoreline and floats and the immediate vicinity of floats. Long distance swimmers with or without swimming aids must be accompanied by a boat and must remain in close proximity to each other.
- 8 • Use of the lake raft is to be done in full accordance with the State Bathing Regulations, N.J.A.C.8:26-1 et seq, Chapter 5 and the State required sign posted on the raft stating: "NO LIFEGUARD ON DUTY - PERSONS UNDER THE AGE OF SIXTEEN MUST BE ACCOMPANIED BY AN ADULT - NO SWIMMING ALONE" L.O.C.A. assumes no responsibility beyond this notification and the posting of the required sign on the raft.
- 9 • Floats shall be firmly anchored and must be kept in line with each other and must bear the LOCA area number. Forms available from the secretary at (973) 948-6866. From December 1 thru March 1 each year all buoys, floating ropes and objects must be removed from the lake.
- 10 • Pollution or desecration of the waters of the lake by any means is absolutely prohibited. Throwing of rubbish of any description into the lake or surrounding areas or allowing sewage effluents to flow into the lake may be cause for loss of membership.
- 11 • Fishing in accordance with State and LOCA Fishing Club regulations is permitted by members and bona fide guests. Early morning fishermen are requested to respect the rights of the sleeping community.
- 12 • Only trolling speed is permitted in the cove at all times. (Little or no wake).
- 13 • All persons using the lake for any purpose does so at their own risk in all respects.
- 14 • See your LOCA By-Laws for detailed rules and regulations.
- 15 • For Winter lake use, please see By-Laws. NOTE: GOING OUT ON LAKE ICE IS DONE AT YOUR OWN RISK
